This revises an existing book that has been a standard reference on nonqualified plans among financial service companies and executive compensation and benefit professionals for more than 25 years. This new edition not only covers the impact of 409A on the design, documentation and administration of nonqualified deferred compensation plans, but also covers all other significant recent developments affecting popular deferred compensation techniques, such as the recent change in proxy disclosure requirements for plans of public companies. This book is an in-depth resource for any attorney, accountant, actuary, consultant, HR or retirement plans financial representative who must work regularly with such plans and are currently dealing with the impact of 409A.

Mr. Richey's most recent 409A book follows the release earlier in the spring of a smaller, briefcase-size edition, *The 409A Advisor*, which was also published by the National Underwriter Company. It is designed as a readable summary of 409A's impact on plans and is intended as a volume-purchase educational piece for financial institutions such as 401(k) providers, insurance carriers and banks, to use with their sales representatives and centers-of-influence.
